Persons' life logics, philologies, philosophies, psychologies are necessary. There were no infinities measurement, no understanding continuum, space, time, motion, change. Worldviewwise necessary Zeno's paradoxes logically refuting motion were unapproachable 25 centuries. Universal vitality and abstractivity with hierarchies are discovered. To comprehend foreign languages using mother tongue support without repression, multilingualism synergy with consonances and associations [1, p. 39–40] helps much, especially the correspondences of languages and speeches to the universe [1–3]. Mythological [5] thinking [1–3], logico-philosophical, psychological, other directions in linguistics [4] are known. Languages as peoples' living souls, arts, mythologies, histories, religions, sciences and ideologies give their worldviews with the pictures of the universe and environment. But common sense is understated [1, p. 90], prejudice [1, p. 526] is considered harmful. There were no exactly measuring the infinite and hence no understanding continuum including space, time, motion and change. Zeno's paradoxes [1, p. 31–32, 190; 2, v. 2, p. 44; 3, p. 39–40] logically refuting motion and change and worldviewwise necessary are 25 centuries unapproachable.

Therefore, all former worldviews are very limited. In wise true nature ordering and by Heraclitus [1, p. 109–110] "everything flows", but in Aristotle's [1, p. 35–38; 3, p. 43–46] logical ordering everything is constant, finite and discrete. James introduced "stream of consciousness" [1, p. 152-153; 6]. Kelly considered the universality of processes, and his constructs [7, 8] improved Aristotle's dichotomies. For half a century de Bono in dozens of books suggests a transition from thinking of Socrates— Plato-Aristotle to the "parallel", "lateral" "de Bono thinking" based on "water logic" [9, 10, etc].

The core of first truly correct namely healing synergistic infinite continuous growing multifaceted multilingual universal life creativing [11–13] is universal philosophy [14] with universal ontology [15], epistemology [16], logic [17], ethics [18], aesthetics [19].

Universal logic in logic in the Heraclitean sense of the Logos [1, p. 134–135, 323–324], "the through semantic ordering of being and consciousness" where "everything flows" in life and according to Heraclitus, identifies partial and personal life logic, general logic with formal deductive, dialectical, inductive logic [3], etc. Universal cognitology in universal philosophy needs universal psychology [20–25], philology [26] with linguistics [27, 28], (meta) metacognitive heuristics of solving Zeno's paradoxes [29, 30] (as well as generalizing analytical methods [31]) with the help of other universal sciences (based on universal philosophy principles) such as universal mathematics [32–38], metrology [39] and physics [40–43] preceded by four articles [44–47] from the Scopus database. Metacognitive heuristics solved Zeno's paradoxes with potential infinities immediately in 1967.

Metametacognitive heuristics solved Zeno's paradoxes with actual infinities in 1994 by defending the Dr. Sc. dissertation and preparing article [32] which grew up to a monograph (both translated into Japanese) with first exactly measuring potential and actual infinities, discovered and invented overinfinities. Hence the healing uniworldview is first true.

For multilingualism, person's life and people's immortality, adequate personal life logics, philologies, psychologies, philosophies, worldviews, pedagogies, sociologies are needed, and for humanity as mankind's survival guarantee also high morality. Experiments [48] at Yale University (whose library represents the author's first two poetry books with forewords by his poetic teacher Boris Chichibabin) with Capuchin monkeys proved that the mania of consumerism with markets, banks and exchanges is not higher than of the animal level. And even below the levels of the vegetable and mineral kingdoms: they are limited to their natural needs only. The author's "leovic": "If life has the size of things, // then a human never wins."

1. LANGUAGE AND SPEECH DENOTATA.

CLASSICAL PHILOSOPHY AND SCIENCE DEFECTS

Language [4, p. 604–608] and speech [4, p. 412–416] express the universe of denotata [4, p. 128–129], philosophic worldview. Existence, being is disconnected by the ultimately general concepts of philosophy (matter, consciousness) and of natural sciences (matter, its attributes: energy, space, time). The main question of philosophy [1, p. 468] in ontology gives the invariable primacy of matter or consciousness (including reflection in allegedly inanimate nature with slow long life in the exchange of the mineral kingdom and man-made objects with the environment whereas the vegetable and animal kingdoms live relatively quickly and briefly) for all objects. But by simultaneity the order primacy is impossible. And the dominating primacy is distinct for different objects.

The main question in epistemology is every object knowability or unknowability completely. But each object (especially a complex one like the psyche of a person and society) is inexhaustible and has an infinite set of properties. However, cognition time, sense organs, devices, thinking, mapping and the transfer of knowledge and experience are limited, and it is reasonable to consider any object at the best only finitely vitally necessarily and sufficiently cognizable as a relative truth and otherwise infinitely mysterious, unknowable. And the essential side of the main question of philosophy is replaced with the cognitive side on the primacy either of an object itself or of the sensation, perception and representation of this object. But by the perception of a given object, its occurrence precedes the sensation, perception and concept of this object because of the finiteness of the speeds of light, sound, smell, data transmission and processing in the cognizing subject. Imagination, however, represents a new object long before its realization which is not necessary.

The universe and its every object have the simultaneous triunity, fusion and integrity of materiality, spirituality (including reflection, information about themselves and surroundings with self-expression) (comm)unity with the impossibility of their precedences. Any side of the triunity can dominate: materiality in a stone with spirituality (reflection, data self-expression) and the unity of parts (on the surface, inside, molecules, atoms, ...); spirituality (content) in a dictum, book, newspaper, file (data set) with the materiality of carriers and unity as a whole; community in a society with the materiality of persons' bodies and spirituality.

Classical philosophy is based on the three not sufficiently general laws of Hegel's dialectics [1–3], but in reality the laws of existence and its being.

A heterogeneous (and not necessarily contradictory) unity can have a multitude of mutually (and not necessarily pairwise) dissimilar (not necessarily opposite to each other) parts with (dis)continuous transitions [14] and only in a particular case two opposites with their often harmful noncompeting struggle, as in the law of unity and struggle of opposites.

Not only quantitative changes, as in the law of the transition of quantitative changes to qualitative changes, but also changes in structure (order) [14] can lead to violation of the measure (steady state) and spasmodic qualitative transformation.

Development can go more successfully not only through the negation of opposites each other with a return to a near initial position and their mutual transformation according to the law of the negation of negation, but also with steadily increasing in overelementary coherence, harmony, cohesion, full cooperation and synergy [14].

Classical philosophy and science cannot solve Zeno's paradoxes [1, p. 31–32, 190; 2, v. 2, p. 44] 25 centuries. These first purely logical proofs refute motion, change, the divisibility of a finity by an infinity [1, p. 17, 52]. There are no exact measurement and distinction in potentially and actually infinitely large and small, no understanding of their essence and continuum [1, p. 275, 433–434], space, time, motion and change.

A continuum of positive dimensions and measures, even an infinite space (and time with eternity), is regarded as completely composed of elements-points (and moments) of zero dimension and measure. But the addition of any set of zeros gives zero only. Galileo [1, p. 99-100] discovered oneto-one correspondence between the countable set of positive integers and its own part, the set of their squares. The conclusion of classical philosophy and science: in the infinite, even countable, a whole not necessarily exceeds its proper (less) part [1, p. 768–769] with no conservation law. Cantor's infinite cardinal numbers [3] only roughly estimate infinities without their exact measurement and do not distinguish the unit segment and the entire space at all.

2. THE ORIGIN OF OWN UNIVERSAL SCIENCES WITH PHILOLOGY AND MULTILINGUALISM

The beginning of personal philology as spoken word love at the levels of perception, memorization and reproduction of poems and fairy tales belongs to the author's early childhood. At the age of five with reading of up to 200 pages a day and presenting children's books on the orders of instructors, a fateful decision to give up checkers in favor of chess with a much more developing strategy led to a leap in personal psychology and personal logic and the author's universal psychology emergence. At the age of twelve, he made a fateful switch from chess finitely rationally restricting free creativity with a starting position, strict rules and too far advanced debut theory, to unlimited own literary and scientific creativity.

Composing poems and stories in Russian and Ukrainian originated creative universal philology [25-28] via personal literaturology. Problems solutions explanations formed universal pedagogy. The same year of 1964 was the origin of universal mathematics with ideas about the non-numerical nature of zero and the useful refusal to divide by zero. In 1967, the author proved the non-cantorality of the set of roots of an equation at their multiplicity, the ambiguity of raising a negative number to an odd power also representable by a fraction with an even denominator. Then he also conceived universal philosophy [14]. At the age of 15 he found first complete solutions (necessary for correct worldview) to Zeno's paradoxes "Dichotomy" and "Achilles and the Tortoise" in article "Aporiya" [1, p. 31–32] on the potentially countable divisibility of a finite interval first in 25 centuries.

In 1968–1969, the author proved the necessity and usefulness of also uncountable operations and the apparent insufficiency of real numbers: in them the probability of an equiprobable choice of one of the elements of an infinite set does not exist. And the probability of an equiprobable choice of one of the points of a continuum is unacceptably considered equal to zero even if such an event is possible and by adding zeros it is impossible to get a unit as the probability of a reliable event. At the same time, the author discovered and proved the necessity and usefulness of the universal emptiness and as the universal inaction abolishing any action. In 1975, the author began with universal informatics, metrology and mechanics and defended them in his Ph. D. dissertation in 1987.

His first English poetry book [49] received positive feedbacks from Oxford University Press and Oxford University as the key step to universal philology [26] with multilingualism. In 1992, universal strength discovered the hierarchy of the first universal strength laws of nature in the history with his first monographs in 1992 in Russian and in 1993 [41] in English. The author's universal mathematics was formed and partially presented with his universal mechanics and strength in 1993 in his Dr. Sc. dissertation successfully defended in 1994 and entirely in English by articles [32, 33] and especially in 1995 by monograph [34]. In 1994, the author discovered and invented exactly universally measuring infinities first in 2500 years and solved all the most difficult Zeno's paradoxes "On the multiplicity of things" and "The Arrow" in articles "Aporiya" and "Zenon Eleyskiy" [1, p. 31–32, 190], as well as in the article "Zenon iz Elei" [2, v. 2, p. 44].

"Meanwhile, the understanding of the fundamental contradiction between the finiteness of a language (as a device, mechanism, system) and its infinite use in infinitely diverse speech situations has far-reaching consequences for a correct understanding of the nature of language, since this contradiction is overcome above all in the language itself, in the principles of its design: all elements of the language structure are adapted to their use in speech" [4, p. 605]. The infinite reflected and expressed via language with speech, which is countable and like rational points of a segment everywhere dense in continuous speech situations, is necessary for understanding the essence of them all and of universal philology [26–28].

3. HEALING UNIVERSAL LIFE CREATIVING AND ITS HIERARCHY CORE, UNIPHILOSOPHY

Universal life creativing as the author's universal sciences hierarchy first discovered and invented [3] the exact universal measurement and discrimination by universal numbers and quantities as universal measures in the potentially and actually infinitely and even overinfinitely large and small, the universal conservation laws and the divisibility of the finite by the (over)infinite. A whole is always greater than its smaller part. The universal composition of a continuum from its arbitrarily finely subdividable commensurate universal particles of actually continuously infinitely small measures without divisibility limit (either mathematical or unimathematical atomism) is also discovered.

First in almost 2500 years, all Zeno's paradoxes were solved and Anaxagoras' ideas on homeomerias were realized [1, p. 22, 121].

The core of the author's universal life creativing hierarchy is healing uniphilosophy [14] (universal wisdom, the universe essence science, the cognition and knowledge methodologies and the logic of them all) of existence and being

as a (comm)unity of materiality and spirituality [1, p. 179], naturalness and supernaturalness, knowability and mystery, knowledge and faith with uniphilological metaphorical high-moral ideal as the origin and with the key role of universal logic.

Uniphilosophy includes:

- 2) unicognition and uniknowledge (universal epistemology) [16] as the universal methodology of the supersensitive world comprehension, the unity of the universal infinite, discovery and invention;
- 3) uniordering (universal correctness, logic) [17] as the key in universal philosophy of the unity of universal lifelogic (world ordering), psychologic (brain and mentality ordering of feeling, thinking and willing), actlogic (activity ordering). Universal philosophy is included in philosophy with singling out in it classical (general) philosophy [1, 2], partial and personal life philosophies.

4. THE DISCOVERY OF THE UNIVERSALITY OF OVERHIERARCHICAL VITALITY

Classical philosophy [1, p. 186–187] and science consider the mineral kingdom and man-made objects to be inanimate, but, contradicting themselves, they are talking about the artificial intellect of man-made objects. Universal life creativing discovered overhierarchical vitality universality. Overhierarchicality is a multilevel subordination with overlevels, levels, underlevels and their orders. Everything that exists is alive because of the exchange with the environment and the objects span of life also relatively slow and long by the mineral kingdom and man-made objects.

Universal vitality overhierarchicality from the top to the bottom is as follows:

- 2. The overlevel of the vegetable kingdom with the level of individual organisms and the supra-organismic level, as well as further classification underlevels by the International Code of Botanical Nomenclature.
- 3. The overlevel of the animal kingdom with the level of an individual organism and the supra-organismic level and further zoological underlevels.

- 6. The overlevel of universal personification with the panvitalism, pananimalism (hylozoism), panpsychism, panlogism [1, p. 476] levels, their abilities underlevels.

5. KNOWN TRUTH CONCEPT DEFECTS. UNIVERSAL TRUTH DISCOVERY

In classical philosophy [1, p. 226–227] and science, truth is knowledge corresponding to existing things as parts of reality. But it is infinitely diverse, heterogeneous, in part even self-contradictory. Then (especially in clearly insufficient two-digit black and white classical logic [3]) it is possible, by the classical definition of truth, to declare everything, even clearly inappropriate, to be truth via indicating or even deliberately artificially building corresponding part of reality as an example.

In universal life creativing and philosophy, a universal truth is defined as knowledge with inherent fidelity, social usefulness and conformity to things as parts of reality.

It is vitally important to call everything by proper names in the native language for feeling and usefulness. This is especially important by truth, since its comprehension is the (un)conscious setting [1, p. 708], the main goal of science, research, cognition.

Abstraction has successive orders on one level of thinking human conceptual only. The abstraction of plurality, conceptuality, associating similar objects into a set for general concept building is wrongly considered the abstraction of identification. Analytic (isolating) abstraction is also synthetic.

Science is unthinkable without measurements, and even a single segment is intensely actually infinite, by the Cantor theorem uncountable, greater than the actual infinity of the natural numbers set [3].

Unilifecreativing and philosophy discovered the universality of abstractions (just as selections) and their second hierarchy by sensation, perception, sensitivity, habit, representation, healing unisense, experience, wisdom, intuition [1, p. 216– 217], foreboding, feeling, vital faith, trust, confident knowledge, uniprejudice, reasoning, understanding, (uni)theorizing with (uni)reflection [14], guesswork (insight [1, p. 209]) partly as reactions to the first hierarchies of mechanical, physical, chemical, biological and social [1, 2] environmental influences, with reflection and self-expression in behavior and in part conscious internal life activity.

Stone and metal change themselves mechanically, physically, chemically and influence back the environment mechanically, physically, chemically, plants and animals biologically, mankind socially. Recognizing influences, selective and thus uniabstract reactions to them via self-expression, behavior and utilization are spontaneous like congenital reflexes and complex unconscious instincts as fruits of supposedly lifeless phylogenesis.

Universal philosophy [14] discovered universal healing sense. It is the readiness of a person to acceptably correctly understanding the vital environment and to desirably successful vital activities following clearly perceived, satisfied and developed own needs, interests with (un)conscious own-life attitude [1, p. 708].

Otherwise, universal healing sense is insufficiently complete with unstable psyche, direct dependence violations including personal dependence (mania becoming a habit like in learning [1, p. 407]), without mental protection. - 3. "Criticism to oneself and to own mental products (activities) and their results." We must add: "reasonable, socially useful, in accordance with the internal and external reality, without excessive, unreasonable, obviously socially and/or personally harmful overstating and understating self-criticism."
- 4. "The correspondence of mental reactions (adequacy) to the strength and frequency of environmental influences, social circumstances and situations." This is in accordance with external reality. Compliance with the inner reality requires the addition: "as well as to own customary conventional physical and mental processes and properties, including temperament, and state."

This is not the case with many persons which are weak (including the elderly), unorganized, subordinate to leaders and/or to the external order, living someone else's life, swimming with the flow without own goals, not accustomed to their own ideas, but mentally healthy. The replacement: "The ability to solve vitally necessary and sufficient problems".

Universal mental health criterion: life activity, including the psyche and behavior, in accordance with universal healing sense and logic, including the ordering of external and internal reality, self-preservation, continuation, self-management, social and personal usefulness, desire.

In universal psychology, the mental health criteria are related to the levels of universal lifepsychoanalysis and lifepsychodiagnostics after intuition and lifepsychocoherence and before lifepsychohealing. The role of universal philology with hermeneutics is great. All of them and other universal sciences are healing along with universal life creativing which together with universal philosophy teaches life.
